- ◆ Primary Member \$120 - Skating members who compete individually or on a team, and/or test, and/or are in Junior Club or Adult Club. Please deduct a discount of \$10.00 if you renew your primary membership by July 15, 2006. Note: Jr. Club & Adult Club skaters will receive this discount at their September registration date.
- ◆ Separate program payment structures are established for Junior Club and Adult Club. If you are a Junior Club or Adult Club member and wish to pay your Primary Member fee before the September registration day, then it will be deducted from your total due.

VOLUNTEER PROGRAM

The BGSC is primarily operated by volunteers. In fact, the success and growth of the club depends on each family committing to support the club through volunteer hours. The BGSC has a mandatory work program for active skaters and each family will be required to put in ten (10) hours for the 2006-2007 season. This year's volunteer program will begin July 1, 2006 and end April 30, 2007. Any family not completing the required hours by the end of the skating season, will be assessed a \$10.00 per hour charge for hours not worked. Each member does have the option to pay for volunteer hours.

Each time you work you will need to fill out a work slip and return it to the chairperson of the committee you worked on. The chairperson will need to sign the slip and you or the chairperson will need to put it in the club mailbox to get your hours recorded. The work slip will tell us which skater it's for, what committee you worked on, and how much time you worked. Blank work slips will be located in the club mailbox in the skate shop.

PLEASE READ THE FOLLOWING AGREEMENT. THIS FORM MUST BE SIGNED AND RETURNED WITH YOUR REGISTRATION FORMS.

1. I understand that by completing the membership packet that the skater is a member of the Bowling Green Skating Club for the entire year. As a member of the Bowling Green Skating Club I agree to complete the mandatory volunteer hours. No one is exempt.
2. I understand that the Bowling Green Skating Club will make every attempt to contact me about volunteer opportunities; however, it is ultimately my responsibility to ensure that I complete the mandatory volunteer hours. I understand that I should pay attention to the club's newsletters, emails, website, and bulletin boards to actively look for volunteer opportunities. I understand that I should contact the Volunteer Committee members or skating club board members to actively look for volunteer opportunities.
3. I understand that it is my responsibility to fill out the necessary paperwork to document the volunteer hours that I complete.
4. At the end of the skating season, I agree to pay the Bowling Green Skating Club \$10 per hour for each hour not worked.
5. I understand that failure to complete the volunteer hours or make payment for volunteer hours not worked will cause the skater to be ineligible to test or compete after June 30, 2007. I also understand that any future membership in the skating club will be denied until all debts have been settled.

- Adhere to the USFSA requirements determined by individual instructors and as outlined in the current USFSA Rulebook.
